REGULATIONS

- Confirmation is open to all pure-bred dogs 3 months of age and over that **HAVE NOT** won major points.
- Agents/professional handlers are only allowed to handle dogs that they own or co-own.
- Wins carry no championship points.
- Dogs must be in proper show clip. No taped ears are allowed in the ring. Spayed or neutered animals **MAY NOT** compete.
- Dogs must **ALWAYS** be on a leash or be crated except when being judged.
- Please keep the park clean so it will be available in the future. Dog scoops will be provided by Chesapeake Virginia Dogs Fanciers Association.
